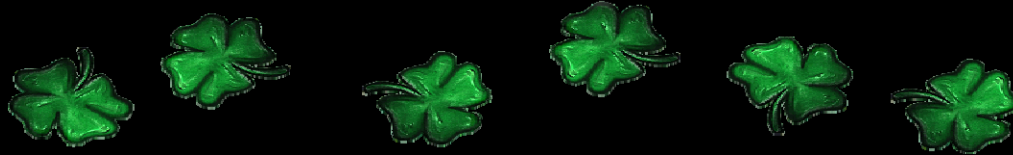

This show shall be governed by the latest revised rules of ABRA. Filling out an entry implies acceptance of these rules and the following:

This is a **DOUBLE** youth show! There will be no grooming or carrying rabbits to the judging table by anyone over the age of 18. This rule will be enforced.

This is a one day carrying cage double show to be held on Saturday, March 7, 2009.

There will be no carriers. You and you alone are responsible for getting your rabbit on and off the table. The show committee is not in the least way responsible for any rabbits that do not show up on the table. There is no numbered cooping area.

The entry fee is \$3.00 per class, \$5.50 for both shows. Fur classes require an additional \$1.50 and will be shown in breed fur. Breeders Class is \$2.50 with only one entry per youth. Entry fees are non-refundable.

All entries are to be postmarked by February 28, 2009. There will be NO PHONE ENTRIES & ABSOLUTELY NO ENTRIES THE DAY OF SHOW, we will accept email entries up to March 3, 2009; however, e-mail entries received after February 28, 2009 will be subject to a late charge. A late charge of \$7.00 per entry will be charged for any entries postmarked or e-mailed after February 28, 2009. Any entries received after March 3, 2009, will be returned to sender and not accepted. Payment must accompany all entries. Payment for e-mail entries must be received by March 6, 2009.

The showroom opens at 7:15 am. All rabbits must be in the showroom by 8:00 am. Judging will commence promptly at 8:30 am. Your rabbit(s) can be released as soon as your cards are processed. Best of Breeds should stay for Best in Show. If you cannot stay please notify the show superintendent, Patrick Hinde.

Rabbits must be permanently earmarked. There shall be absolutely no tattooing, nursing or pregnant does, or breeding allowed in the showroom! Only official service dogs will be allowed. The show committee reserves the right to have a rabbit removed from the showroom for being ill and/or under eight weeks of age.

There is no payback. First through sixth place ribbons are available upon request while they last. All specials must be picked up at the show. Show Reports and Legs will be mailed.

No persons will be allowed behind the judging tables except the show committee.

Rabbits are entered at the exhibitor's own risk. The show personnel, sponsors, and judges are not responsible for death, injury, or loss of any nature. This applies to death, accident, or providential destruction. Parents are responsible for their children and the children in their charge.

No smoking or alcoholic beverages will be allowed in the show room.

Entries may be made on the entry form provided in this catalog or on a separate sheet of paper as long as all proper information is provided. Please, only one exhibitor per entry form. You must provide the ear number, breed, variety/group, sex, class, exhibitor's name, address and phone number.

Changes can be made by phone until 8:00 pm March 5, 2009 (provided the rabbit is in the same breed, class, sex and variety) by calling the show secretary. If your entry is incomplete you will get a collect call.

Ear changes must be made on both the show card and control sheet. Ear changes are the responsibility of the owner.

Absolutely NO chairs, playpens, or tables are allowed. No grooming tables. Don't bring them and you won't have to pack them out. All carrying cages must have solid, leak-proof bottoms.

No booths or sales areas will be allowed inside or out, without the authorization of the Show Committee.

Any Rabbit that is for sale MUST be entered, and must be at least eight weeks of age. There will be no selling of rabbits in the building or parking lot unless said rabbit is entered in the show and at least eight weeks of age.
